What's required...

Parks Victoria are seeking 2-4 professional rock climbers to disguise chalk and remove bolts from Cultivation Creek 19 VAHR 7323-0091 (also known as Millennium Caves) - a rock art shelter located in the Grampians (Gariwerd) National Park. This will take place over two weeks between 22 May – 9 June.

There are approximately 50 bolts located over 10 climbs at Cultivation Creek and significant area of of chalk stains. Climbing anchors will be removed by cordless drill or cut with cordless angle grinder, and any holes left by the removal methods will be filled with sandstone coloured silicone. Chalk will be disguised by painting over the chalked area with pigments or coloured chalk.

Parks Victoria will supply equipment to remove bolts and disguise chalk such as drills, drill bits, angle grinder, hammer, holepunch silicone, and coloured chalk / pigments.

Contractor will supply all their own climbing safety equipment including cut proof ropes, harnesses, helmets etc.

Staff from Parks Victoria, Barengi Gadjin Land Council Aboriginal Corporation, Gunditj Mirring Traditional Owners Aboriginal Corporation, and Eastern Maar Aboriginal Corporation will be onsite throughout the works.

The contracted time will be each day from 9am - 4pm.
